The descriptive key below explains the meaning of the information in this List of Permitted Hazardous & Connecticut-Regulated Waste Transporters:

Column Heading	Meaning of the Information in the Column
Permit No.	The transporter's Connecticut Hazardous Waste Transporter Permit Number.
EPA ID	The transporter's U.S. EPA ID Number.
Transporter Name	The transporter's company name as identified on their transporter permit.
Site Street Address	The transporter's site address.
Town	The town or city in which the permittee is located.
State	The state in which the permittee is located.
Phone No.	The phone number at which the permittee can be contacted.
PED	Permit Expiration Date (the date that the transporter's permit will expire).
N	A check mark means that the transporter is permitted to transport non-RCRA-hazardous CT Regulated Waste.
H	A check mark means that the transporter is permitted to transport hazardous waste.
SP	A check mark means that the transporter is a permitted spill cleanup contractor.

**NOTE:** Since all Connecticut waste transporter permits are waste-specific, you should verify with your transporter that the wastes to be transported are listed on the transporter's permit before using their services. You should also verify that the vehicle(s) to be used are in compliance with US DOT Hazardous Materials Requirements, and that the transporter has the proper insurance coverage.

This is only a partial listing of transporters that are permitted in Connecticut. This list has been established for general reference only and should not be used as an ultimate verification source (i.e., you may want to request a current copy of the waste transporter's permit from the hauler you intend to use). Please be aware that this listing may change from day to day; however, due to resource constraints, this list is only updated weekly. In addition, this list should not be construed to be a recommendation from the Waste Engineering & Enforcement Division of any services provided.
