Minutes of Non-Inmate Absolute Pardon Hearing for July 26, 2016

The Chairperson called the meeting to order at 09:08 a.m. and declared the presence of a quorum. Dorigene LaRosa served as Secretary for the purpose of recording and transcribing minutes.
