## Minutes of Non-Inmate Full Hearing Summer Session August 26, 2015

The Chairperson called the meeting to order at 9:07 a.m. and declared the presence of a quorum. Dorigene LaRosa served as Secretary for the purpose of recording and transcribing minutes. The agenda was a public hearing of all cases scheduled for pardon consideration on the August 26, 2015 Pardons Hearing docket.
