Minutes of Non-Inmate Absolute Hearing for October 18, 2016

The Chairperson called the meeting to order at 9:09 a.m. and declared the presence of a quorum. Dorigene LaRosa served as Secretary for the purpose of recording and transcribing minutes. The agenda was a public hearing of all cases scheduled for pardon consideration on the October 18, 2016 Pardons Hearing docket.
