

## NOTICE TO ALL CERTIFICATION CANDIDATES

In an effort to better meet the needs of Connecticut's Fire Service, The Commission is working to improve the **Written Examination Scores Results Notification** process. Within the next 18 months we anticipate fully automating certification examination results reporting. Until that time we will begin posting examination results on our web page. To insure anonymity for the Certification Candidate we are limited in the type and amount of data we may release.

The written certification examination scores can be accessed through the [ct.gov/cfpc](http://ct.gov/cfpc) website and clicking **Certification** then clicking **Written Exam Scores Results**.

### **Reading the Relevant Data and Information:**

To insure confidentiality, a format has been designed for quickly "looking up" score results. At the top of each page is the date and location of the written examination. In the columns below the heading are test score results and the Certification Candidate's four-digit Identification number. If the Certification Candidate participated in a multi-level examination (Trench I/II) or a combination examination (Fire Fighter I HM/WMD Awareness and Operations Level), there are several columns with the designated heading and scores. In either situation to successfully complete the entire examination ALL scores must be at least 70% or greater (further explanation below).

### **Please Read Me First!**

#### **General Information: Written Examination Results and Retesting**

Scores listed in this document are provided in a confidential format (e.g., Student four-digit ID#) as a courtesy and are to be considered **unofficial** until receipt of written documentation from the Certification Division via U.S. Mail.

**Official notification** of a written examination score will be mailed to the Certification Candidate in six to eight weeks following the date of the examination; the CFPC Release of Test Scores Authorization Form (C-15) is no longer available.

At present, Certification Candidates who fail a written examination and require retesting **must** await receipt of written examination scores mailed from the Certification Division prior to applying for re-examination; any application for re-examination based solely on the electronic display of examination results cannot be accepted.

### **Retesting Reminders:**

Certification Candidates who fail any component of the Awareness and Operations level Hazardous Materials/Weapons of Mass Destruction (HM/WMD) written examination as it applies to Fire Fighter I certification are not eligible for Fire Fighter I certification until all components of the Awareness and Operations Level HM/WMD are attained.

Certification Candidates who fail any component of the Fire Fighter I, Fire Fighter I and II or Fire Fighter I/II levels are not eligible for Fire Fighter II certification until all components of the Fire Fighter I level, including the Awareness and Operations Level Hazardous Materials/Weapons of Mass Destruction, are attained.

Certification Candidates who fail any level of a multi-level written examination (e.g., Rescue Technician: Trench I/II) are not eligible for certification until all components for all levels are attained.

### **Eligibility Period:**

To be re-examined in any State of Connecticut certification written examination within twelve (12) months of the date of the Lead Instructor's signature on the original certification application does not require re-examination of the practical skills portion. Once the 12-month period has lapsed, the individual shall be required to retake the applicable training course before the certification application process can be activated. (Due to the nature of its practical examination, the Fire Officer IV level has a 24-month eligibility period.) There is no extension to these eligibility periods.
