2015 CPAT schedule

The Connecticut Fire academy offers a spring and a fall testing cycle. Each cycle consists of two orientations, two practice tests, and the CPAT test. Each testing cycle has an application deadline. The 2015 application deadlines are February 26, 2015 for the spring testing cycle and July 23, 2015 for the fall testing cycle. Applications received after appropriate deadline will not be accepted. Candidates will receive a packet with the dates and times of their CPAT sessions within two weeks of the application deadline. **If you do not receive your packet you must contact the Connecticut Fire Academy to verify your registration within 30 days of the application deadline.**

Returned check policy

A \$25.00 fee will be assessed to all returned checks (insufficient funds, stop payment, etc). In order to complete your registration after the receipt of a returned check, you must submit cash, money order, or a bank check including the amount of tuition and the returned check fee to the registrar.
