1. \$160 if licensee's expiration/birthday was prior to October 1, 2009.
2. \$320 if licensee's expiration/birthday is October 1, 2009 or later.

**Nonresident Producer Renewals ONLY:** Please note that while NIPR is transitioning to the new fee schedule for NRR's (Non-Resident Renewals), if a deficient renewal fee is collected through the NIPR Gateway, then the Licensee will receive an invoice directly from the State of Connecticut Insurance Department which must be paid to validate the online renewal application. If invoiced, payment (in the form of a check or money order) must be forwarded directly to the Connecticut Insurance Department and cannot be made online. **\*\* Appointment Fee and Appointment Renewal Fee (Foreign Companies):**

1. \$80.00 - if the premium tax rate in the appointing company's state of domicile is equal to or greater than CT's 1.75% premium tax rate.
2. \$20.00 - if the premium tax rate in the appointing company's state of domicile is less than CT's 1.75% premium tax rate
