

Directions to Site**



To Site

From Enfield: I-91 south to I-84 west to Route 72 west to end of expressway; turn right and follow Rte 72; at Rte 229 turn left and then immediate right under RR bridge to continue following Rte 72 to North Main Street; turn right onto North Main Street to North Street (Route 6); turn left on North St (Jake's Steak and Seafood and Bank of America are on opposite corners); follow Route 6; take first left after crossing reservoir onto Bushnell Street (Terrybles Motorcycle Apparel is on corner); follow Bushnell Street to stop sign; turn left onto Makara St. (no street sign); at Y bear left to Pequabuck Golf Club; follow road past clubhouse to end of parking area.

From Hartford: I-84 west to Route 72 west; then follow Enfield directions.

From Stonington: I-95 south to Rte 9 north to New Britain; switch to Route 72 west; then follow Enfield directions.

From Meriden: I-91 north to Rte 9 north to New Britain; switch to Route 72 west; then follow Enfield directions.

From Wolcott: take Rte 69 north to Rte 6 in Bristol; turn left onto Rte 6; then follow Enfield directions.

From Northwest and Southwest: Route 8 to Exit 39 (Route 6); from south, turn right to travel east on 6; from north turn left; follow Route 6 to Bristol city line; turn right onto Bushnell Street at Terrybles Motorcycle Apparel; then follow Enfield directions.

To Hearing

Retrace steps to Rte 6; turn right; follow to North Main Street (Bank of America on left, North Side Square on opposite corner to right) and turn right; city hall will be on right after post office and police station; discount supermarket is opposite.

To Dinner:

Dinner is at Jake's Steak and Seafood at corner of North Street (Route 6) and North Main Street.
