AN APPLICATION OF CABLEVISION OF CONNECTICUT, LIMITED PARTNERSHIP, FOR A CERTIFICATE OF ENVIRONMENTAL COMPATIBILITY AND PUBLIC NEED FOR THE ERECTION OF A COMMUNITY ANTENNA TELEVISION TOWER AND ASSOCIATED EQUIPMENT IN EASTON, CONNECTICUT. : CONNECTICUT SITING COUNCIL : November 10, 1986

DECISION AND ORDER

Based on the findings of fact and Council opinion in this docket, the Council hereby directs that a Certificate of Environmental Compatibility and Public Need, as provided by section 16-50k of the General Statutes of Connecticut, be issued to Cablevision of Connecticut for the construction, operation, and maintenance of a Cable Antenna Television Tower (CATV) and associated equipment in the Town of Easton, Connecticut.

The facility shall be constructed, operated, and maintained as specified in the Council's record in this matter; shall be limited to a 12-foot diameter antenna mounted on a ten-foot by ten-foot by ten-foot concrete block equipment building and electronic equipment, including six 12 Gigahertz transmitters and one Hughes AML broadband receiver, within the equipment building; and shall be subject to the following conditions:

1. The antenna shall be no larger than necessary to provide the proposed service, and in no event shall exceed 12 feet in diameter;
2. The certificate holder shall notify the Council before any additional equipment not listed above is added;
3. The facility construction shall be conducted in accordance with all applicable federal, state, and municipal laws and regulations;
4. The certificate holder shall file with the Council a development and management plan which (a) includes the planting of evergreens to screen the facility, and (b) provides a fence of adequate height to prevent direct public exposure to the beam at the site;

5. Construction activities shall take place during daylight hours;  
and
6. This Decision and Order shall be void if all construction  
authorized is not completed within three years of the issuance of  
this decision.

Pursuant to section 16-50p of the General Statutes, we hereby direct  
that a copy of this Decision and Order shall be served on each person  
listed below. A notice of this issuance shall be published in the  
Bridgeport Post.
