

TO HEARING LOCATION:

Via Route 15 South (from all points east of Stamford)

Proceed on Route 15 South.
Take Exit 35 (High Ridge Road / Route 137) off of Route 15 South.
At the end of the ramp, turn right onto High Ridge Road (Route 137).
Proceed on High Ridge Road (Route 137) for approximately 0.8 miles.
Turn left onto Vine Road.
Proceed on Vine Road for approximately 0.3 miles.
You will see a sign for the Ferguson Library and Turn of River School on the right.
Turn right at the sign and proceed to the Ferguson Library.
Parking is just past the library on the right side.

Via Route 15 North (from all points west of Stamford)

Proceed on Route 15 North.
Take Exit 35 (High Ridge Road / Route 137) off of Route 15 North.
At the end of the ramp, turn right onto High Ridge Road (Route 137).
Proceed on High Ridge Road (Route 137) for approximately 0.7 miles.
Turn left onto Vine Road.
Proceed on Vine Road for approximately 0.3 miles.
You will see a sign for the Ferguson Library and Turn of River School on the right.
Turn right at the sign and proceed to the Ferguson Library.
Parking is just past the library on the right side.

Via Interstate 95 South (from Milford and all points east of Milford)

Proceed on I-95 South.
Take Exit 38 (Milford Parkway / Route 796) off of I-95 South.
Follow the Milford Parkway connector until it ends.
Merge onto Route 15 South.
Proceed on Route 15 South.
Take Exit 35 (High Ridge Road / Route 137) off of Route 15 South.
At the end of the ramp, turn right onto High Ridge Road (Route 137).
Proceed on High Ridge Road (Route 137) for approximately 0.8 miles.
Turn left onto Vine Road.

Proceed on Vine Road for approximately 0.3 miles.
You will see a sign for the Ferguson Library and Turn of River School on the right.
Turn right at the sign and proceed to the Ferguson Library.
Parking is just past the library on the right side.

Via Interstate 91 South (from Meriden and all points north of Meriden)

Proceed on I-91 South.
Take Exit 17 (Route 15 South) to Route 15 South.
Proceed on Route 15 South.
Take Exit 35 (High Ridge Road / Route 137) off of Route 15 South.
At the end of the ramp, turn right onto High Ridge Road (Route 137).
Proceed on High Ridge Road (Route 137) for approximately 0.8 miles.
Turn left onto Vine Road.
Proceed on Vine Road for approximately 0.3 miles.
You will see a sign for the Ferguson Library and Turn of River School on the right.
Turn right at the sign and proceed to the Ferguson Library.
Parking is just past the library on the right side.

**TO: Parkway Diner and Restaurant – 1066 High Ridge Road, Stamford
From Hearing Location (Ferguson Library)**

Turn left onto Vine Road.
Proceed 0.3 miles on Vine Road.
Turn right onto High Ridge Road.
Proceed straight on High Ridge Road for approximately 0.4 miles.
Parkway Diner is on the left and located at 1066 High Ridge Road.
