TO FIELD REVIEW FROM MERRITT PARKWAY

From Merritt Parkway traveling south

Take Exit 41.

Bear right off exit, follow Route 33 south under the bridge.

After bridge, turn left at traffic light and turn left into Park & Ride lot adjacent to the highway.

From Merritt Parkway traveling north

Take Exit 41.

Bear right and turn into Park & Ride lot on right.

TO FIELD REVIEW FROM I-95

Take Exit 17.

Follow Route 33 north to Merritt Parkway.

Park and Ride lot is on right before Merritt Parkway overpass.

TO TOWN HALL FROM PARK & RIDE - EXIT 41

Turn right out of Park & Ride lot.

Turn left at light onto Route 33 south.

At traffic light, take left onto Route 57 north.

At next traffic light bear right onto Kings Highway.

Take right onto Main Street (traffic light).

At next traffic light, take left onto Avery Place.

At stop sign, take left.

Town Hall is on right – take first driveway and park in rear.

TO TOWN HALL FROM MERRITT PARKWAY

Take Exit 42 and follow Route 57 south

Follow Route 57 to Y intersection- bear left onto Main Street. Route 57 goes right. (Bogey's is on corner)

At second light, take left onto Avery Place.

At stop sign, take left.

Town Hall is on right – take first driveway and park in rear.

TO TOWN HALL FROM I-95

Take Exit 17.

Follow Route 33 north to Route 57 north.

Follow Route 57 north to Kings Highway (traffic light).

Bear right onto Kings Highway.

Take right onto Main Street (traffic light).

At next traffic light, take left onto Avery Place.

At stop sign, take left.

Town Hall is on right – take first driveway and park in rear.

PETITION 809 FIELD REVIEW ITINERARY

From the Park and Ride lot, turn right and follow to light.

At light, turn right and follow Route 33 north under bridge to highway southbound ramp.

Follow Merritt Parkway to Exit 36 - cable mounted antennas would be placed on the following bridges:

Newtown Turnpike	(first bridge - Node 1)
Grumman Avenue	(bridge 2 - Node 3)
East Rocks Road	(bridge 3 - Node 4)
Comstock Hill Road	(bridge 5 - Node 5)
Nursery Street	(bridge 7- Node 7)
White Oak Shade Road	(bridge 8 - Node 8)
South Avenue	(bridge 9 - Node 9)
Lapham Road	(bridge 10 - Node 10)

Take Exit 36. Bear right at end of exit onto Old Stamford Road.

After bridge, turn left onto Talmadge Hill Road.

At stop sign turn left onto Lapham Road.

Park along road by overpass.


After site discussion, return to Talmadge Hill Road.

Turn right and follow downhill to Old Stamford Road.

Turn right to get on Merritt Parkway heading north.

Follow Merritt Parkway to Exit 41.
