**MOTION OF THE TOWN OF BOZRAH FOR PARTY STATUS**

The Town of Bozrah ("Bozrah") hereby moves the Connecticut Siting Council ("Council") to designate Bozrah as a party in the above captioned proceeding pursuant to Connecticut General Statute §§ 16-50n and 4-177a and the Regulations of Connecticut State Agencies § 16-50j-14. In support of this motion Bozrah states the following:

1. The Council established this proceeding to consider the application of SolarCity Corporation Petition for a Declaratory Ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed construction and operation of a 3.1 Megawatt Community Shared Solar Photovoltaic Electric Generating Facility located on Brush Hill Road in Bozrah, Connecticut ("Petition").
2. Bozrah seeks to participate on behalf of the interests of its 2600 residents. Bozrah's residents shall be specifically affected by the Council's decision and its

participation in this proceeding is necessary to represent the interests of those residents.




