

Lodestar Energy LLC ("Lodestar Energy") has transferred to LSE Canis Major LLC ("Canis Major") the planned Solar Project at 1005 North Street, Suffield, Connecticut (the "Project"), including assignment of the Declaratory Ruling issued by the Siting Council on September 9, 2015, regarding Petition 1159 (the "Declaratory Ruling"). Canis Major is a wholly-owned subsidiary of Lodestar Energy, such that Lodestar Energy is Canis Major's sole Manager. This transaction was finalized on April 1, 2016.

Lodestar Energy is current with payments to the Siting Council for annual assessments and invoices under Conn. Gen. Stat. § 16-50v associated with the Project. Accordingly, pursuant to the terms of the Declaratory Ruling, Canis Major hereby requests that the Siting Council transfer the Declaratory Ruling from Lodestar Energy to Canis Major.

Canis Major hereby confirms its agreement to comply with the terms, limitations and conditions contained in the Declaratory Ruling, including timely payments to the Council for annual assessments and invoices under Conn. Gen. Stat. § 16-50v.


