

Page 13 of PSEG Connecticut LLC's ("PSEG") Technical Report to the City of Bridgeport, Exhibit H to PSEG's Petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance and operation of a new 485 megawatt (MW) dual fuel combined-cycle electric generating facility at the existing Bridgeport Harbor Station located at 1 Atlantic Street, Bridgeport, Connecticut (the "Petition"), states that:

"Based on capacity selected by the ISO-NE in the FCA conducted in February, 2015, capacity prices are already committed to rising by more than 400% from approximately \$10 per kW-Month now to \$52 per kW month beginning in June 2018."


This sentence should instead read as follows:

"Based on capacity selected by the ISO-NE in the FCA conducted in February, 2015, capacity prices are already committed to rising by more than 175% from approximately \$3.4 per kW-month now to \$9.5 per kW-month beginning in June, 2018 in Connecticut, and more than 400% to \$17.73 per kW-month for new resources in neighboring Rhode Island and Southeastern Massachusetts."
