RE: **PETITION NO. 1218** – PSEG Power Connecticut LLC petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance, and operation of a new 485 megawatt (MW) dual fuel combined-cycle electric generating facility at the existing Bridgeport Harbor Station located at 1 Atlantic Street, Bridgeport, Connecticut.

The Connecticut Siting Council (Council) has scheduled a field inspection for May 5, 2016, at 2:00 p.m. to review this petition. Boots are suggested. Interested parties should enter at the security gate for PSEG near the end of Atlantic Street. Council members and staff, parties/intervenors and all members of the public must present photo identification to PSEG security at the gate. After entering the gate, drive straight and then take the first right and proceed towards the proposed power plant site with the four existing fuel tanks. (See Google Earth photo.)

The Council respectfully requests that members of the public that wish to attend the field review contact Robert Silvestri at PSEG no later than May 3, 2016 so that PSEG security has the names on file to check against photo IDs on the day of the field review. A public hearing is scheduled for May 5, 2016, beginning with an evidentiary session at **3:00 p.m.** and a **public comment session at 7:00 p.m.** at the Bridgeport City Hall, Council Chambers, 45 Lyon Terrace, Bridgeport, Connecticut.

### **TO FIELD REVIEW – 1 Atlantic Street, Bridgeport**

#### **Via Route 8 South (including Interstate 84 and Route 15 connections):**

Proceed on Route 8 South.  
Take Exit 1 (Prospect Street / Myrtle Avenue) off of Route 8 South.  
At the end of the exit ramp, proceed straight onto Myrtle Avenue.  
Proceed on Myrtle Avenue for approximately 0.4 miles.  
Turn left onto Atlantic Street.  
Proceed straight on Atlantic Street for approximately 0.35 miles.  
Arrive at the security gate for PSEG.

#### **Via Interstate 95 South (all points east of Bridgeport including Interstate 91 South connection):**

Proceed on Interstate 95 South.  
Take Exit 27 (Lafayette Blvd/Downtown Bridgeport) off of I-95 South.  
The exit ramp forks. Bear left towards Transportation Center.  
At the end of the exit ramp, turn left onto Lafayette Street.  
Proceed on Lafayette Street for approximately 0.36 miles.  
Turn left onto Atlantic Street.  
Proceed on Atlantic Street for approximately 0.21 miles.  
Arrive at the security gate for PSEG.

#### **Via Interstate 95 North (all points west of Bridgeport):**

Proceed on Interstate 95 North.  
Take Exit 27 (Lafayette Blvd/Harbor Yard) off of I-95 North.  
At the end of the exit ramp, turn right onto Myrtle Avenue.  
Proceed on Myrtle Avenue for about 0.27 miles.  
Turn left onto Atlantic Street.  
Proceed on Atlantic Street for approximately 0.35 miles.  
Arrive at the security gate for PSEG.



**TO HEARING LOCATION – Bridgeport City Hall  
Council Chambers  
45 Lyon Terrace  
Bridgeport, Connecticut**

**From Site:**

Exit via Atlantic Street. (The existing Bridgeport Energy plant is on your right.)  
Turn right onto Main Street.  
Take your first left onto Cottage Place.  
Take the first right onto Broad Street.  
Proceed on Broad Street for about 0.16 miles.  
Immediately after passing under the railroad tracks, turn left onto Railroad Avenue.  
Proceed on Railroad Avenue for about 0.15 miles.  
Turn right onto Warren Street.  
Proceed on Warren Street for about 0.23 miles.  
Merge onto Route 8 North.  
Immediately take Exit 2 (Golden Hill Street/Main Street) off of Route 8 North.  
At the end of the exit ramp, proceed straight across onto Golden Hill Street.  
Proceed on Golden Hill Street for about 0.1 miles.  
Turn left onto Lyon Terrace.  
Proceed on Lyon Terrace for about 0.1 miles.  
Just past the City Hall is the North Parking Lot.  
Turn left into the City Hall North Lot Visitors Parking.

**Via Route 8 South (including Interstate 84 and Route 15 connections):**

Take Route 8 South to Exit 3 (towards Washington Avenue).

After 0.2 miles, the exit ramp forks. Bear left for the Main Street South ramp towards East Washington Avenue.

Continue straight until the ramp ends at a traffic light.

Continue straight onto Main Street.

Proceed on Main Street for about 0.4 miles.

Turn right onto Golden Hill Street.

Proceed on Golden Hill Street for about 0.1 miles.

Turn right onto Lyon Terrace.

Proceed on Lyon Terrace for about 0.1 miles.

Just past the City Hall is the North Parking Lot.

Turn left into the City Hall North Lot Visitors Parking.

**Via Interstate 95 South (from points east of Bridgeport including Interstate 91 South connection):**

Take I-95 South to Exit 27A (Route 8 and Route 25 towards Trumbull/Waterbury)

Take Exit 2 (Golden Hill Street towards Main Street/Washington Avenue).

At the end of the exit ramp, continue straight across to Golden Hill Street.

Proceed on Golden Hill Street for about 0.1 miles.

Take the first left onto Lyon Terrace.

Proceed on Lyon Terrace for about 0.1 miles.

Just past the City Hall is the North Lot Visitors Parking.

**Via Interstate 95 North (from points west of Bridgeport)**

Take I-95 North to Exit 27A (Route 8 and Route 25 towards Trumbull/Waterbury)

Take Exit 2 (Golden Hill Street towards Main Street/Washington Avenue).


At the end of the exit ramp, continue straight across to Golden Hill Street.

Proceed on Golden Hill Street for about 0.1 miles.

Take the first left onto Lyon Terrace.

Proceed on Lyon Terrace for about 0.1 miles.

Just past the City Hall is the North Lot Visitors Parking.



**TO: Ralph ‘n Rich’s Restaurant – 815 Main Street, Bridgeport**

**From Hearing Location (Bridgeport City Hall):**

Exiting the North Parking Lot, turn right onto Lyon Terrace.

Proceed on Lyon Terrace for about 0.1 miles.

Turn left onto Golden Hill Street.

Proceed on Golden Hill Street for about 0.13 miles.

Turn right onto Main Street.

Proceed on Main Street for about 0.33 miles.

Turn right onto Cesar Batalla Way.

Take the first left into the gated parking area for Ralph ‘n Rich’s Restaurant.
