

RE: **DOCKET NO. 317** - The United Illuminating Company application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a proposed 115-kV/13.8-kV electric substation and associated facilities located at 3-7 Wildflower Lane, Trumbull, Connecticut.

The Connecticut Siting Council has scheduled a field review for this docket for Tuesday, October 24, 2006, beginning at 1:00 p.m. at the primary site (Site 1) located at 3-7 Wildflower Lane, Trumbull and continuing to Site 6 which will be accessed from Quail Trail.

NEW INFORMATION: The field review will then continue to a third site, the Quarry Road site (Site 11).

Council members will meet at the end of Wildflower Lane, in the cul-de-sac, at 1:00 p.m. (After reviewing Site 1 from Wildflower Lane, Council members and any interested parties also may wish to review Site 1 from the cul-de-sac at Stella Street Ext.)

The field review will continue to Quail Trail to allow Site 6 to be reviewed and finally to Site 11. Council staff will provide guidance via a vehicle escort to Sites 6 and 11. Boots are recommended. The field review will then continue to the Quarry Road site.

NEW INFORMATION: A public hearing is scheduled for Tuesday, October 24, 2006, beginning at 3:00 p.m. at the Madison Middle School Auditorium, 4630 Madison Avenue, Trumbull, Connecticut.

TO FIELD REVIEW (Site 1) – 3-7 Wildflower Lane

From Northwest Connecticut (Norfolk Area):

Take Route 44 East to Route 8 South.
Proceed on Route 8 South for approximately 53 miles.
Take Exit 8 (Route 108) off of Route 8.
Take Route 108 North Ramp toward Trumbull.
Turn Left onto Route 108 (Nichols Ave).
Proceed straight 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Fairfield Area:

Take Route 15 North (Merritt Parkway).
Follow Route 15 North for approximately 4.9 miles.
Take Exit 51 (Nichols Avenue) off of Route 15.
Proceed straight for 0.2 miles.
Turn right onto Huntington Turnpike (Route 108).
Bear right to continue onto Huntington Turnpike.
Proceed straight for 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Northern Connecticut (Enfield Area):

Take Interstate 91 South.
Follow I-91 South for approximately 33 miles.
Take Exit 17 (Route 15 South) off of I-91.
Proceed on Route 15 South for approximately 30.2 miles.
Take Exit 52 (Route 8 South) towards Route 108/Bridgeport.
Proceed straight for 0.6 miles.

Take Route 108 Exit towards Stratford.
Proceed straight for 0.1 miles.
Turn right onto Nichols Avenue (Route 108).
Proceed straight for 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Meriden Area:

Take Interstate 91 South.
Take Exit 17 (Route 15 South) off of I-91.
Proceed on Route 15 South for approximately 30.2 miles.
Take Exit 52 (Route 8 South) towards Route 108/Bridgeport.
Proceed straight for 0.6 miles.
Take Route 108 Exit towards Stratford.
Proceed straight for 0.1 miles.
Turn right onto Nichols Avenue (Route 108).
Proceed straight for 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Ansonia Area:

Take Route 8 South for about 8 miles.
Take Exit 8 (Route 108) towards Route 15.
Proceed straight for 0.2 miles.
Take Route 108 North ramp towards Trumbull.
Turn left onto Route 108 (Nichols Avenue).
Proceed straight for 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for 0.3 miles.
Turn let onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Wolcott Area:

Take Route 69 South to Interstate 84 West.
Take I-84 West to Route 8 South.
Take Exit 8 (Route 108) towards Route 15.
Proceed straight for 0.2 miles.
Take Route 108 North ramp towards Trumbull.
Turn left onto Route 108 (Nichols Avenue).
Proceed straight for 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for 0.3 miles.
Turn let onto Wildflower Lane.

The site is located at the end of Wildflower Lane at the cul-de-sac.

From Milford Area:

Take Route 1 (Boston Post Road) to Milford Parkway.
Proceed straight for about 2.2 miles.
Take the left exit onto Route 15 South.
Proceed straight for about 3.8 miles.
Take Exit 52 (Route 8 South towards Route 108 South).
Proceed straight for about 0.6 miles.
Take Route 108 exit towards Stratford.
Proceed straight for about 0.1 miles.
Turn right onto Route 108 (Nichols Avenue).
Proceed straight for about 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for about 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Stonington Area:

Take Interstate 95 South for about 64 miles.
Take Exit 38 towards Route 15.
Proceed straight for about 0.2 miles.
Merge onto Milford Parkway.
Proceed straight for about 1.6 miles.
Take the left exit onto Route 15 South.
Proceed straight for about 3.8 miles.
Take Exit 52 (Route 8 South towards Route 108 South).
Proceed straight for about 0.6 miles.
Take Route 108 exit towards Stratford.
Proceed straight for about 0.1 miles.
Turn right onto Route 108 (Nichols Avenue).
Proceed straight for about 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for about 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Ridgefield Area:

Take Route 7 South to Route 15 North.
Take Exit 51 (Route 108) towards Nichols Avenue.
Proceed straight for about 0.2 miles.
Turn right onto Route 108 (Huntington Turnpike).
Take another quick right to stay on Huntington Turnpike.
Proceed straight for about 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Southington Area:

Take Interstate 84 West to Route 8 South.
Proceed on Route 8 South for about 25 miles.
Take Exit 8 (Route 108) towards Route 15N/Stratford/Merritt Parkway.
Proceed straight for 0.2 miles.
Take Route 108 North ramp towards Trumbull.
Turn left onto Route 108 (Nichols Avenue).
Proceed straight 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight 0.3 miles.
Turn left onto Wildflower Lane.
The site is located at the end of Wildflower Lane at the cul-de-sac.

From Council Office in New Britain:

Take Route 71 North to Route 9 South.
Take Route 9 South to Interstate 91 South.
Take Interstate 91 South to Route 15 South.
Proceed on Route 15 South for about 30 miles.
Take Exit 52 towards Route 108 South (Bridgeport).
Proceed straight for about 0.6 miles.
Take Route 108 exit towards Stratford.
Proceed straight for about 0.1 miles.
Turn right onto Route 108 (Nichols Avenue).
Proceed straight for about 0.2 miles.
Turn left onto Huntington Turnpike.
Proceed straight for about 0.3 miles.
Turn left onto Wildflower Lane
The site is located at the end of Wildflower Lane at the cul-de-sac.

TO Stella Street from 3-7 Wildflower Lane (Site 1)

Proceed to the beginning of Wildflower Lane.
Turn left onto Huntington Turnpike.
Proceed straight about 900 feet.
Turn left onto Stella Street.
Proceed to the end of the Stella Street.

TO Quail Trail (Site 6) from Stella Street or 3-7 Wildflower Lane (Site 1)

Proceed to the beginning of Stella Street or Wildflower Lane.
Turn left onto Huntington Turnpike.
Proceed straight about 0.2 to 0.3 miles.
Turn right onto Beardsley Parkway.
Proceed straight about 0.3 miles.
Bear right onto Reiner Drive.
Proceed straight about 0.1 miles.
Turn right onto Reiner Circle.
Proceed straight about 0.1 miles.

Turn left onto Oak Ridge Road.
Proceed straight about 0.1 miles.
Take first right onto Hillston Road.
Proceed straight about 0.1 miles.
Take first left onto Bobwhite Lane.
Proceed straight about 0.1 miles.
Turn right on Quail Trail.
Proceed to the cul-de-sac at the end of Quail Trail.

TO Quarry Road (Site 11) from Site 6 – Quail Trail

Proceed straight on Quail Trail.
Quail Trail becomes Foster Avenue.
Proceed straight about 0.1 miles.
Turn left onto Leffert Road.
Proceed straight about 0.1 miles.
Turn left onto Unity Road.
Proceed straight about 0.1 miles.
Bear left onto Route 127 (White Plains Road).
Proceed straight for approximately 0.8 miles.
Turn right onto Old Town Road.
Take the first right onto Trumbull Road.
Proceed straight. Trumbull Road becomes Quarry Road.
Proceed to the end of Quarry Road.
The site is at the end of Quarry Road.

TO HEARING LOCATION – Madison Middle School Auditorium, 4630 Madison Ave., Trumbull

From Site 11 – Quarry Road

Proceed south on Quarry Road for about 0.5 miles.
Quarry Road becomes Trumbull Road.
Turn right onto Old Town Road.
Take Route 25 North towards Route 15 South.
Proceed for approximately 0.5 miles.
Take Exit 7 (Route 15 South and Route 127).
Proceed straight for about 0.5 miles.
Merge onto Route 15 South.
Proceed for 1.6 miles.
Take Exit 48 (Route 111 / Main Street).
Turn right onto Main Street (Route 111).
Turn left onto Chestnut Hill Road.
Proceed straight for about 0.5 miles.
Turn right onto Madison Avenue.
Proceed straight for about 1.7 miles.
The school is located at 4630 Madison Avenue, Trumbull.

From Route 15 South

Take Exit 48 (Route 111 / Main Street).
Turn right onto Main Street (Route 111).
Turn left onto Chestnut Hill Road.
Proceed straight for about 0.5 miles.
Turn right onto Madison Avenue.
Proceed straight for about 1.7 miles.
The school is located at 4630 Madison Avenue, Trumbull.

TO OLD TOWNE RESTAURANT – 10 Quality Street

From Hearing Location (Madison Middle School Auditorium)

Proceed north on Madison Avenue towards Anita Avenue.
Proceed straight for 0.4 miles.
Turn right on Lake Avenue.
Proceed straight for 1.2 miles.
Turn right onto Main Street.
Proceed for 0.7 miles.
Turn left onto Quality Street.
