

TO FIELD REVIEW – 1662 Gold Star Memorial Highway, Groton

From I-95 Northbound

Follow I-95 north to exit 88 for Route 117
Turn left onto Route 117 driving north
Follow Route 117 to intersection with Route 184 (Gold Star Highway) at Center Groton
Turn right onto Route 184
Follow Route 184 to #1662 on the left (an orange cone will be at the end of the driveway)

From I-95 Southbound

Follow I-95 south to exit #89 (Route 27)
Turn right onto Route 27 (Whitehall Avenue)
Follow Route 27 to Route 184
Bear left onto Route 184 (Gold Star Highway)
Follow Route 184 to #1662 on the right (an orange cone will be at the end of the driveway)

TO GROTON SENIOR CENTER HEARING SITE

From Field Review Site

Turn right out of driveway onto Route 184
Follow to intersection with Route 117
Turn right onto Route 117
Drive past I-95
The Groton Senior Center is #102, on the right

From I-95 Northbound

Follow I-95 to exit # 88 (Route 117)
Turn right onto Route 117 (North Road)
The Groton Senior Center is #102, on the right

From I-95 Southbound

Follow I-95 south to exit #88 (Route 117)
Turn left onto Route 117 (North Road)
The Groton Senior Center is #102, on the right
