Please note that this is a follow up letter to one dated February 20, 2007. That letter contained a typographical error whereby an erroneous proposed tower location was listed rather than the actual proposed location at 1294 Pleasant Valley Road North, Groton, Connecticut. The text below is what that notice should have said. We sincerely apologize for any confusion this error may have caused.

Pursuant to Section 16-50/ of the Connecticut General Statutes, as an abutting property owner, this is to notify you that, Optasite Towers LLC, with a principal place of business at One Research Drive, Suite 200C, Westborough, MA 01581 and Omnipoint Communications, Inc. with a Connecticut office at 100 Filley Street, Bloomfield, CT 06002 (collectively the "Applicants"), will file an application with the Connecticut Siting Council regarding a parcel of property located at **1294 Pleasant Valley Road North, Groton, Connecticut**. The application will be submitted to the Connecticut Siting Council on or about February 20, 2007 and the Applicants will request to be put on a future agenda.

NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on February 20, 2007 or thereafter by Optasite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants"). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Groton, Connecticut. The Applicants are proposing to construct a new monopole tower at 1294 Pleasant Valley Road North, Groton, Connecticut and is owned by JFM Enterprises, LLC. (the "Property"). The Applicants propose to construct a new 140' self-supporting monopole, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g *et. seq.*

The proposed facility would provide personal wireless communication service in the Towns of Groton and Ledyard along route 12 and State Highway 32, as well as in adjacent areas. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Groton. The balloon will be flown from approximately 12 p.m. to 5 p.m. Notice of the public hearing date will be provided by the Siting Council.


