

RE: **DOCKET NO. 331** - Sprint Nextel Corporation application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 836 Foxon Road, East Haven, Connecticut.

I. Introduction

The application is from the Sprint Nextel Corporation for the construction, maintenance, and operation of a telecommunications facility and associated equipment in the Town of East Haven, Connecticut.

Sprint Nextel proposes to erect a 100-foot flagpole telecommunications within a 20-foot by 20-foot equipment compound that would be located next to a commercial building used as a health club on a three acre parcel zoned for single family residential use.

II. Technical

The application includes relevant maps, descriptions of the proposed prime and alternate site, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. Council staff believes additional information can be obtained through pre-hearing interrogatories. This project would not require an outside consultant.

III. Administrative Review

The applicant has stated that all service and filing requirements pursuant to General Statutes § 16-501 (b) have been fulfilled. The applicant stated that notice to the general public was published in the New Haven Register and the East Haven Courier.

IV. Procedural

The Council must schedule a hearing for the proceeding between 30 and 150 days after receipt of an application. The Council must also appoint a custodian of the docket and designate a place for the deposition of the transcript. Staff recommends designating Adriana Popa as custodian of the docket, holding the public hearing in the Town of East Haven on Tuesday, August 14, 2007, and depositing the transcript in the East Haven and New Haven Town Halls.
