

TO FIELD REVIEW: 16 MOUNTAIN ROAD

From New Britain- Waterbury Areas

Follow Interstate 84 west to Exit 17, Route 64.
Follow Route 64 west to Route 6.
Follow Route 6 east through Woodbury Center to Route 47.
Follow Route 47 north through Washington Depot to Route 202.
Follow Route 202 west past New Preston into Marble Dale.
At blinking yellow light, turn right onto Findlay Street.
Follow Findlay uphill and take second right onto Mountain Road.
Follow to end and bear right - park in field below the pool.

From Bridgeport Area

Follow Interstate 95 to Route 8 north.
Follow Route 8 north to Route 25 north.
Follow Route 25 north through Newtown to Route 133 in Brookfield.
Follow Route 133 north (may be designated east) to Route 67. (*Route 133 avoids construction related delays on Route 7/202*)
Follow Route 67 north (or west) to Route 202 in New Milford.
Follow Route 202 east to Marble Dale.
At blinking yellow light, turn left onto Findlay Street.
Follow Findlay uphill and take second right onto Mountain Road (caution-narrow rd)
Follow to end and bear right - park in field below the pool.

From New Haven, Derby Areas

In New Haven, follow Interstate 95 to Route 34 west.
Follow Route 34 west into **Derby**.
From Derby, follow Route 8 north to exit 22, Route 67.
From Exit 22, follow Route 67 north (or west) to Route 6 in Southbury.
Follow Route 6 east to Route 47 in Woodbury.
Follow Route 47 north through Washington Depot to Route 202.
Follow Route 202 west past New Preston into Marble Dale.
At blinking yellow light, turn right onto Findlay Street.
Follow Findlay uphill and take second right onto Mountain Road (caution-narrow rd)
Follow to end and bear right - park in field below the pool.

TO SITE 2 FROM SITE 1

Follow Findlay Road downhill to Route 202 at blinking light.
Go straight across Route 202.
Turn left onto Scofield Hill Road (first left).
Turn left onto Mygatt Road (first left).
Follow Mygatt Road to end and park along right side.

From Site 2


From Mygatt, turn right onto Route 202 east and follow to Route 47 south.
Follow Route 47 south into Washington Depot.
At stop sign, go right and turn immediately left into Bryan Hall Plaza. Town Hall is on right.

From Waterbury – New Britain Areas

Follow Interstate 84 west to Exit 17, Route 64.
Follow Route 64 west to Route 6.
Follow Route 6 east through Woodbury Center to Route 47.
Follow Route 47 north into Washington Depot.
At stop sign, go straight and turn left onto Bryan Hall Plaza.
Town Hall is on the right.

From Bridgeport, Derby Areas

Follow Route 8 north to Exit 22, Route 67.
