



PUBLIC NOTICE APPLICATION FOR CERTIFICATE OF ENVIRONMENTAL COMPATIBILITY AND PUBLIC NEED CONCERNING A COMMUNITY ANTENNA TELEVISION HEAD-END FACILITY IN THE TOWN OF MONTVILLE

Notice is hereby given pursuant to Chapter 277a Sections 16-50k et seq. of the Connecticut General Statutes, and Regulations pertaining thereby, of an application to be filed on or about April 13, 2007 with the Connecticut Siting Council by MetroCast Communications of Connecticut, LLC ("MetroCast"). This Application will seek approval to expand an existing head-end facility to include nine (9) new 4 meter satellite earth stations and related electronic head-end equipment, all for the purpose of enhancing and consolidating cable television service in the MetroCast franchise area, and will provide the Connecticut Siting Council with jurisdiction over the existing tower located at the site. This Application does not include construction of a new tower. The proposed site of these facilities is 689 Old Colchester Road in Uncasville-Montville, Connecticut, which property currently owned and occupied by MetroCast (the Applicant).
