


AFFIDAVIT OF NOTICE TO ABUTTING PROPERTY OWNERS

The undersigned, being duly sworn, deposes and says:

1. I am an attorney representing MetroCast Communications of Connecticut, LLC (“MetroCast”).
2. That on April 10, 2007, I mailed by certified mail an abutter notification letter dated April 10, 2007 to the mailing addresses of the abutting property owners to 689 Old Colchester Road, Uncasville-Montville, Connecticut as indicated in the records of the Montville Assessor’s Office. The names of the abutting property owners receiving this notification are listed in Exhibit 5 – Abutter Information Listing.
3. That on April 12, 2007, I mailed by certified mail an abutter notification letter dated April 12, 2007 to the mailing addresses of the abutting property owners to 689 Old Colchester Road, Uncasville-Montville, Connecticut as indicated in the records of the Montville Assessor’s Office. The names of the abutting property owners receiving this notification are listed in Exhibit 5 – Abutter Information Listing.
4. That on April 17, 2007, it was discovered that Exhibit 5 as filed with the Connecticut Siting Council on April 13, 2007, required three corrections. The three corrections, and the corresponding remedial action taken by MetroCast if needed, are:
 - a. David Apanashk, owner of 654 Old Colchester Road, was inadvertently omitted from Exhibit 5. While Mr. Apanashk is not a direct abutter, MetroCast decided to notice all abutters within 500 feet of the site. Abutter notification letters providing Mr. Apanashk with notice of MetroCast’s Application were sent, by certified mail, return receipt requested, to his address on April 20, 2007, and April 23, 2007. MetroCast already has received the return certified receipt for the letter sent on April 20, 2007.
 - b. The mailing address of Robert C. and Janet A. Eccleston as stated on Exhibit 5 was incorrect. The correct mailing address is 135 Fellows Road, Oakdale, CT 06370. This error was a transcription error that did not affect the notices sent to the Eccleston’s on April 10, and April 12, 2007. In fact, MetroCast already has received the returned certified receipt for both letters
 - c. The mailing address of Alan Wojciechowski as stated on Exhibit 5 was incorrect. The correct mailing address is 568 Route 163, Montville, CT 06353. Abutter notification letters providing Mr.

Wojciechowski with notice of MetroCast's Application were resent, by certified mail, return receipt requested, to the correct address on April 20, 2007, and April 23, 2007.

5. That the letters referenced above served as notice of MetroCast's application to The Connecticut Siting Council as required by the statutes and regulations of the State of Connecticut.
