

Field Review and Hearing Directions**



**To Site**

**From Southwest, Central, Northwest:** Travel I-84 eastbound to Exit 69 (Rt. 74 to Rt. 44, Willington); turn right at end of exit ramp to follow Route 74 southbound to Route 44; turn left onto Route 44 to travel eastbound; site is behind Midway Restaurant, on right hand side of 44 shortly after traffic light at intersection with Route 89.

**From Enfield:** Travel Route 190 eastbound to Route 32 southbound to Route 74 southbound to Route 44; turn left onto Route 44 to travel eastbound; site is behind Midway Restaurant, on right hand side of 44 shortly after traffic light at intersection with Route 89

**From Stonington:** Travel Route 201 northbound to I-395 northbound to Exit 93 (Route 101); take Route 101 westbound to Route 44 westbound; once in Ashford, look for Midway Restaurant on left side of road.

**To Hearing**

Knowlton Memorial Town is at intersection of Routes 44 and 89; from site, turn left onto 44; turn left into first driveway beyond traffic light at intersection of Routes 44 and 89; hearing is in stone building to right. *(to ice cream—Ashford Dairy Bar is approximately 2 miles east of site on 44, turn right instead of left from site)*

**To Restaurant**

Dinner will be at Zenny's Restaurant, 625 Middle Turnpike (Route 44) in Mansfield; from hearing turn left onto 44 and follow into Mansfield; Zenny's is on northwest corner of intersection of Routes 44 and 195; travel through intersection, restaurant will be immediately on right.
