Cellco Partnership d/b/a Verizon Wireless (“Cellco”) will be submitting an application to the Connecticut Siting Council (“Council”) on or about September 14, 2007, for approval of the construction of a telecommunications facility on property at 700 Kent Road/15 South Kent Road, New Milford, Connecticut owned by the Gaylordsville Fire Department (“GVFD”).

The proposed facility would consist of a 120-foot self-supporting monopole and a 12’ x 30’ equipment shelter all within a 50’ x 50’ site compound within a 100’ x 100’ leased area. The tower would be designed to accommodate multiple wireless carriers and will be used to support the GVFD emergency service antennas.

The location and other features of the proposed facility are subject to change under the provisions of Connecticut General Statutes § 16-50g *et seq.*

State law provides that owners of record of property which abuts a parcel on which the proposed facility may be located must receive notice of the submission of this application. This notice is directed to you either because you may be an abutting land owner or as a courtesy notice.
