Dear Attorney Fitzgerald and Attorney Henebry:

Section 16-50j-60(d) of the Regulations of Connecticut State Agencies, entitled, "Timing of plan" states: "The d&m plan shall be submitted to the council in one or more sections, and the council shall approve, modify, or disapprove each section within 45 days after receipt of it...."

The current deadline for the Council to approve, modify or disapprove the above mentioned D&M Plan is September 13, 2010. Due to the complex nature of this docket and the volume of material contained in the D&M Plan, the Connecticut Siting Council (Council) will need additional time to review the D&M Plan. The Council hereby requests an extension of the decision deadline for the Docket 370 D&M Plan for the Greater Springfield Reliability Project and the North Bloomfield Substation until October 29, 2010.
