Via Interstate 84 from areas north and east of Hartford

Follow I-84 to Exit 39 (Route 4)
Follow Route 4 west to Route 177 in Unionville.
Follow Route 177 north for approximately 3 miles, past Country Club Road.
Church will be on right after Greenwood Lane.
Site is to rear.

Via Interstate 84 from areas south and west of Southington/Plainville

Follow I-84 to Route 72 west.
Take Exit 1 for Route 177.
Turn right onto Route 177 north and follow into Unionville.
Continue on Route 177 for 3 miles past Unionville.
Church will be on right after Greenwood Lane.
Site is to rear.

TO SENIOR CENTER

From Site

From Church, turn left onto Route 177 south –travel ~3/4 mile.
Turn left Country Club Road.
Turn right onto West Avon Road (Route 167).
At second light, turn right into Senior Center Complex (Sycamore Hills Road).
Senior Center is first building to left.

Via Interstate 84 from areas north and east of Hartford

Follow I-84 to Exit 39 (Route 4)

Follow Route 4 west to Route 167.

Follow Route 167 north to Sycamore Hills Road on left (at light).

Senior Center is first building to left.

Via Interstate 84 from areas south and west of Southington/Plainville

Follow I-84 to Route 72 west.

Take Exit 1 for Route 177.

Turn right onto Route 177 north and follow into Unionville.


Turn right onto Route 4 east.
