Dear Chairman Robert Stein and Members of the Connecticut Siting Council:

On behalf of SBA Towers III (“SBA”) and New Cingular Wireless PCS, LLC (“AT&T”) we respectfully submit the attached drawing and request approval of a minor alteration in the approved Design and Management Plan compound configuration for the Facility approved in Docket 412. As previously planned and indicated to the Council, construction for the site did commence this summer but to date that work is focused on the replacement of the existing bridge. Work on the compound will ensue after the bridge replacement and access drive are constructed.

As depicted on the attached drawing prepared by CHA dated May 22, 2013, AT&T’s shelter will be rotated 180 degrees and shifted slightly north; essentially swapping places with the approved generator pad and generator. The resulting configuration will require a slightly longer cable bridge but does not impact the ability for other carriers to co-locate within the approved compound. This reconfiguration is requested at the behest of AT&T as it is a better organization of the equipment in relationship to the utility routing from the meter board. No other changes to the approved D&M plan are proposed.


