Dear Ms. Roberts:

Prior to the close of the June 7, 2011 Public Hearing in Bloomfield, Councilman Brian Golembiewski asked the Applicant to explore with the property owner alternative cell site locations on the 10.8 acre subject parcel. Specifically, we were asked to investigate alternative locations that would provide more of a buffer between the tower site and residences along Adams Road to the south and Tunxis Avenue to the west.

My client and its consultant team have been working for the last several weeks with the property owner to identify alternative locations that would satisfy the Mr. Golembiewski's objectives and not adversely affect the property owner's plans to develop this parcel in the future. Late yesterday, following a lengthy meeting at the site and the completion of additional field work by the development team, Cellco was able to identify an alternative cell site location for the Council's consideration located on approximately 350 feet north of the location proposed in Docket No. 416.

We are in the process of complying information regarding this alternative cell site location and its environmental impacts, including visual impacts on the property and the surrounding area. We do not, however, expect that this new information will be available by the close of the Council's record on July 7, 2011. I will not therefore, be filing, on behalf of the Applicant, a Post-Hearing Brief or Proposed Findings of Fact at this time.
