### **TO FIELD REVIEW – 186 Black Rock Turnpike, Redding, CT**

#### **From Northwest Connecticut:**

Take Route 8 South to Interstate 84 West.  
Proceed on I-84 West.  
Take Exit 9 (Route 25) off of I-84 West.  
At the end of the exit ramp, turn left onto Hawleyville Road (Route 25).  
Proceed on Route 25 for about 0.5 miles until it ends.  
Turn right onto Mount Pleasant Road (Route 6).  
Follow Mount Pleasant Road about 1.2 miles to the Bethel Town Line.  
Continue on Mount Pleasant Road for about 0.25 miles.  
Turn left onto Old Hawleyville Road.  
Follow Old Hawleyville Road (approx. 2.4 miles) until it ends.  
Turn right onto Route 302 (Dodgingtown Road).  
Proceed on Route 302 for about 1.1 miles to the Bethel Town Line.  
Proceed on Route 302 for about 0.25 miles.  
Turn left onto Route 58 (Putnam Park Road).  
Proceed on Route 58 for about 2.5 miles to the Redding Town Line.  
Route 58 becomes Black Rock Turnpike.  
Continue on Route 58 for about 3.1 more miles until you reach the Redding Fire Department at 186 Black Road Turnpike.  
The Fire Department is on the left.

#### **From Southeast Connecticut:**

Take Interstate 95 South to Exit 38 (Route 15).  
Follow connector to Route 15 South.  
Proceed on Route 15 South for about 11.1 miles.  
Take Exit 44 off of Route 15 South.  
Turn left onto Congress Street.  
Turn right onto Black Rock Turnpike (Route 58).  
Follow Route 58 for about 7.7 miles until you reach the Redding Town Line.

Proceed on Route 58 for about 1.80 miles until you reach the Redding Fire Department at 186 Black Rock Turnpike.

The Fire Department is on the right.

**From Northern and Central Connecticut:**

Take I-91 South to Route 15 South.

Proceed on Route 15 South for about 11.1 miles.

Take Exit 44 off of Route 15 South.

Turn left onto Congress Street.

Turn right onto Black Rock Turnpike (Route 58).

Follow Route 58 for about 7.7 miles until you reach the Redding Town Line.

Proceed on Route 58 for about 1.80 miles until you reach the Redding Fire Department at 186 Black Rock Turnpike.

The Fire Department is on the right.

**From Milford Area:**

Take Route 15 South.

Take Exit 44 off of Route 15 South.

Turn left onto Congress Street.

Turn right onto Black Rock Turnpike (Route 58).

Follow Route 58 for about 7.7 miles until you reach the Redding Town Line.

Proceed on Route 58 for about 1.80 miles until you reach the Redding Fire Department at 186 Black Rock Turnpike.

The Fire Department is on the right.

**From Stamford Area:**

Take Route 15 North.

Take Exit 44 off of Route 15 North.

Turn left onto Congress Street.

Turn left onto Route 58 (Black Rock Turnpike).

Follow Route 58 for about 7.8 miles until you reach the Redding Town Line.

Proceed on Route 58 for about 1.80 miles until you reach the Redding Fire Department at 186 Black Rock Turnpike.

The Fire Department is on the right.

**From Council Office:**

Take Route 71 North to Route 9 South.

Take Route 9 South to Interstate 91 South.

Take I-91 South to Route 15 South.

Proceed on Route 15 South.

Take Exit 44 off of Route 15 South.

Turn left onto Congress Street.

Turn right onto Black Rock Turnpike (Route 58).

Follow Route 58 for about 7.7 miles until you reach the Redding Town Line.

Proceed on Route 58 for about 1.80 miles until you reach the Redding Fire Department at 186 Black Rock Turnpike.

The Fire Department is on the right.



**TO HEARING LOCATION – Redding Community Center, Community Room, 37  
Lonetown Road, Redding, Connecticut**

**From Site**

Turn right onto Black Rock Turnpike (Route 58).  
Proceed about 0.3 miles on Black Rock Turnpike.  
Turn left onto Cross Highway.  
Proceed about 1.9 miles on Cross Highway until it ends.  
Turn right onto Route 107 (Hill Road)  
Proceed on Route 107 for about 0.55 miles.  
You will pass by the Redding Elementary School on the left.  
The sign and entrance for Redding Community Center is immediately past the school on the left.  
The Redding Community Center is located behind the Redding Elementary School.

**Via Route 15 Southbound**

Take Route 15 South.  
Take Exit 44 off of Route 15 South.  
Turn left onto Congress Street.  
Turn right onto Black Rock Turnpike (Route 58).  
Follow Route 58 for about 7.7 miles until you reach the Redding Town Line.  
Proceed on Route 58 (Black Rock Turnpike) for about 2.1 miles.

Turn left onto Cross Highway.

Proceed about 1.9 miles on Cross Highway until it ends.

Turn right onto Route 107 (Hill Road)

Proceed on Route 107 for about 0.55 miles.

You will pass by the Redding Elementary School on the left.

The sign and entrance for the Redding Community Center are immediately past the school on the left.

The Redding Community Center is located behind the Redding Elementary School.

### **Via Interstate 84 Westbound**

Proceed on I-84 West.

Take Exit 9 (Route 25) off of I-84 West.

At the end of the exit ramp, turn left onto Hawleyville Road (Route 25).

Proceed on Route 25 for about 0.5 miles until it ends.

Turn right onto Mount Pleasant Road (Route 6).

Follow Mount Pleasant Road about 1.2 miles to the Bethel Town Line.

Continue on Mount Pleasant Road for about 0.25 miles.

Turn left onto Old Hawleyville Road.

Follow Old Hawleyville Road (approx. 2.4 miles) until it ends.

Turn right onto Route 302 (Dodgingtown Road).

Proceed on Route 302 for about 1.1 miles to the Bethel Town Line.

Proceed on Route 302 for about 0.25 miles.

Turn left onto Route 58 (Putnam Park Road).

Proceed on Route 58 for about 2.5 miles to the Redding Town Line.

Proceed about 0.3 miles on Route 58.

Turn right onto Route 107 (Putnam Park Road).

Proceed about 0.85 miles on Route 107 (Putnam Park Road).

Turn left onto Lonetown Road to stay on Route 107.

Proceed on Lonetown Road (Route 107) for about 1.4 miles.

The sign and entrance for the Redding Community Center are on the right.

The Redding Community Center is located behind the Redding Elementary School.



## TO Whitlocks Restaurant – 273 Route 302 (Greenwood Avenue), Bethel

### From Hearing Location (Redding Community Center)

Turn left onto Lonetown Road (Route 107).

Proceed on Lonetown Road for about 2.2 miles to the Bethel Town Line.

Lonetown Road becomes Chestnut Ridge Road.

Proceed on Chestnut Ridge Road for about 2.3 miles.

Turn left onto Route 302 (Greenwoods Avenue).

Proceed on Route 302 (Greenwoods Avenue) for about 0.9 miles.

Whitlocks is located on the right in a plaza just past the Bethel Cinema.

Whitlocks is located at 273 Greenwood Avenue (Route 302), Bethel.
