Bridgeport, a wholly-owned, indirect subsidiary of LS Power, is an independent power producer that has been granted exempt wholesale generator status and market-based rate authority by the Federal Energy Regulatory Commission. As such, Bridgeport does not have load obligations or a franchised service territory and does not estimate peak load requirements or margins for the Connecticut bulk electric supply system in the regular course of business.
