

Pursuant to provisions of General Statutes § 8-16-50k, and Section 16-50j-21 of the Regulations of Connecticut State Agencies, notice is hereby given that the Connecticut Siting Council (Council) will conduct a public hearing on November 16, 2006, beginning at 2:00 p.m. and continued at 7:00 p.m. at the Plainfield Town Hall Auditorium, 8 Community Avenue, Plainfield, Connecticut and thereafter as necessary on a petition for a declaratory ruling, filed by Plainfield Renewable Energy LLC, that no Certificate of Environmental Compatibility and Public Need is required for the construction and operation of a 37.5 MW wood biomass fueled gasification power plant in the Town of Plainfield. The Council will conduct a public field review of the site on November 16, 2006, beginning at 1:00 p.m. starting at the gate located on Mill Brook Road just west of the intersection of Mill Brook Road and State Route 12 (Norwich Road).

The hearing will consider the applicant's contentions that no significant adverse environmental effects would result from the construction and operation of a 37.5 MW (net) wood biomass fueled gasification power plant off Norwich Road (Map 10, Block 30, Lot 32) in the Town of Plainfield.
