DANIEL DONOVAN, being duly sworn, states:

1. I am the managing member of NuPower LLC, 20 Marshall Street, Suite 300, Norwalk, CT. I am joint owner of Plainfield Renewable Energy LLC ("PRE"). I am over the age of eighteen years and understand the obligations of making statements under oath.


2. Pursuant to the Connecticut Siting Council's (the "Council") July 16, 2008 pre-hearing memorandum and at the request of Derek Phelps, the Council asked PRE to undertake various actions to provide notice of an August 14, 2008 public hearing on the motion to reopen Petition 784. Specifically, the Council asked PRE to provide notice of the public hearing and a brief description of the proposed facilities to abutters to the power plant and the water diversion facility, by certified mail. At the July 28, 2008 pre-hearing conference, The Friends of the Quinebaug River ("FQR"), requested that PRE place notice in *The Turnpike Buyer* of the August 14, 2008 public hearing. The Council requested that, in

addition to notifying the abutters to the power plant and the water diversion facility, PRE notify the abutters to the pipeline connecting the two sites along portions of Packer Road in Canterbury, and portions of Packerville Road, Lillibridge Road, and Mill Brook Road in Plainfield. The Council also requested that signs be erecting at the water diversion facility on the Man-Burch Property in Canterbury and at the power plant facility in Plainfield.

3. On either August 5 or 6, 2008, notice of the August 14, 2008 public hearing will be published in *The Turnpike Buyer*. A copy of the notice is attached as Exhibit A.

4. On July 31, 2008, letters providing notice of the August 14, 2008 public hearing and a brief description of the proposed facilities were sent via certified mail, return receipt requested, to the abutters to the power plant, the water diversion facility, and the pipeline connecting the two sites. A list of these property owners and the certified mail receipts are attached as Exhibit B.

5. On July 30, 2008, a sign measuring two feet by three feet was placed at the water diversion facility on the Man-Burch Property in Canterbury, and a sign measuring four feet by eight feet was placed at the power plant in Plainfield. The language of the signs and photographs of the signs are attached as Exhibit C.

NOTICE OF PUBLIC HEARING
PETITION 784MR

Plainfield Renewable Energy LLC is providing notice of a public hearing regarding the Connecticut Siting Council's declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance and operation of a 37.5 megawatt wood biomass fueled gasification power plant in Plainfield, Connecticut, issued by the Council on June 7, 2007, as Petition No. 784.

The power plant will be located on property on the north side of Mill Brook Road, in Plainfield (the former Gallup Quarry), approximately 300 feet from the intersection with Route 12. The intake/outfall structure and pump house will be located on property on the west side of Packer Road, in Canterbury, approximately 3,000 feet from the border with Plainfield. An underground pipeline connecting the two sites will travel along portions of Packer Road in Canterbury, and portions of Packerville Road, Lillibridge Road, and Mill Brook Road in Plainfield.

A public hearing is being held to hear evidence as to whether conditions have changed such that the Council should conduct further proceedings to examine whether its original decision should be reversed or modified. The public hearing will be held by the Connecticut Siting Council on August 14, 2008 at the Connecticut Siting Council, Hearing Room 1, 10 Franklin Square, New Britain, at 1:00 p.m.
