---

### **From the East (Meriden)**

Take I-84 west to Exit 21 (Meadow Street/Bank Street).  
At end of ramp, take left onto Meadow Street.  
Turn right at light onto Bank Street  
Turn left into FW Webb parking lot before train trestle.  
Ansonia Copper/Brass is to left- proceed through open gate and  
drive around between both buildings to rear parking lot.

### **From the West (Southbury)**

Take I-84 east to Exit 21 (Meadow Street/Bank Street)  
Turn left at end of exit.  
Turn right at light onto Bank Street  
Turn left into FW Webb parking lot before train trestle.  
Ansonia Copper/Brass is to left- proceed through open gate and  
drive around between both buildings to rear parking lot.

### **From the South (Derby)**

Take Route 8 north to I-84 east.  
Take Exit 21 (Meadow Street/Bank Street)  
Turn left at end of exit.  
Turn right at light onto Bank Street  
Turn left into FW Webb parking lot before train trestle.  
Ansonia Copper/Brass is to left- proceed through open gate and  
drive around between both buildings to rear parking lot.

### **From the North (Torrington)**

Take Route 8 south to Exit 30 (West Main Street)  
Take left onto West Main St.  
Take right onto Meadow Street.  
Turn right at light onto Bank Street  
Turn left into FW Webb parking lot before train trestle.  
Ansonia Copper/Brass is to left- proceed through open gate and  
drive around between both buildings to rear parking lot.

## **TO HEARING LOCATION – Sovereign Bank Building.**

**Brass City Room is on second floor of bank building, not City Annex. Either go through lobby of bank from City Annex or use entrance doors at front of building.**

### **From Site**

Turn right out of lot onto Bank Street.

Turn left at light onto Meadow Street (Home Depot).

Go past I-84 entrance ramps and take next right onto Field Street (right after overpass).

At next intersection (Grand Street), go straight onto Leavenworth Street.

Take next left onto Kendrick Avenue.

Park on right behind Sovereign Bank building. **Use outer parking spaces away from doors.**

### **From I-84 going east or Route 8 going north.**

From Route 8 north, get on 84 eastbound.

From I-84 eastbound, take Exit 21.

Turn right at end of ramp.

Take next right onto Field Street (right after overpass).

At next intersection (Grand Street), go straight onto Leavenworth Street.

Take next left onto Kendrick Avenue.

Park on right behind Sovereign Bank building. **Use outer parking spaces away from doors.**

### **From Route 8 going south**

Take Exit 30, West Main Street

Take left onto West Main Street

Take right on Leavenworth Street

Take right on Kendrick, park behind bank. **Use outer parking spaces away from doors.**

### **From I-84 going west**

Take Exit 21.

Take right onto Field Street.

At next intersection (Grand Street), go straight onto Leavenworth Street.

Take next left onto Kendrick Avenue.

Park on right behind Sovereign Bank building. **Use outer parking spaces away from doors.**
