AFFIDAVIT OF KRISTIN M. MOW


I, the undersigned, KRISTIN M. MOW, being duly sworn, hereby depose and say:

1. I am over the age of eighteen, believe in the obligation of an oath, and am competent to attest to the matters stated herein, having direct knowledge of these matters.
  2. I am a Party to the above-noted Connecticut Siting Council proceeding and am concerned about the potential placement of wind turbines near my family's home.
  3. I submit this affidavit in support of the appended Motion for Protective Order and to File Medical Records Under Seal.
  4. The records submitted to the Connecticut Siting Council contain confidential medical information which cannot be subject to public disclosure and review.
-  I have been personally involved with the medical care, treatment and diagnosis of my 9-year old son, Daniel, for Benign Paroxysmal Vertigo ("BPV"). It was first diagnosed and treated when he was 4 years old in October 2006. I was involved with his initial diagnosis, with his treatment, and I continue my involvement with his condition to this date.
6. I have received and reviewed Daniel's medical records since he was born, have been the custodian of those records and continue to be the primary custodian of his medical records.

7. I have submitted seven (7) copied pages of medical records from Connecticut Children's Medical Center related to Daniel's BPV to the Connecticut Siting Council for admission in this action under seal, to be protected as confidential.


