On February 10, 2011, after due notice, the Department of Consumer Protection, Liquor Control Commission, held a formal administrative hearing on charges of violation of (A) Incident of April 28, 2010: (1) Sec .30-6-A24(a) of the Regulations of Connecticut State Agencies, (2) Sec. 30-20(b) of the Connecticut General Statutes, (3) Sec. 30-6-A41(a) of the Regulations of Connecticut State Agencies, (4) Sec. 30-76 of the Connecticut General Statutes, (5) Sec .30-77 of the Connecticut General Statutes; and (B) Incident of September 24, 2010: (6) Sec. 30-6-A24(a) of the Regulations of Connecticut State Agencies, (7) Sec. 30-20(b) of the Connecticut General Statutes, (8) Sec. 30-6-A41(a) of the Regulations of Connecticut State Agencies, (9) Sec. 30-76 of the Connecticut General Statutes and (10) Sec.30-77 of the Connecticut General Statutes. Proper notice of the hearing was provided to the Respondent, however, the Respondent failed to appear at the hearing.

Based upon the testimony and documents submitted at the hearing, the department finds that the respondent in violation of all charges as alleged and **ORDERS** the grocery store beer permit **revoked immediately** in accordance with § 30-6-A8(c) of the Regulations of Connecticut State Agencies.
