- Connecticut Consumer Protection Occupational Trades license counts as of June 6, 2012.
- **Sec. 20-338c. Work not to commence until permit obtained.** No person licensed pursuant to sections 20-330 to 20-341, inclusive, shall commence work within the scope of sections 20-330 to 20-341, inclusive, unless each applicable permit with respect to the specific work being performed by such licensee has been obtained as required pursuant to local ordinances and the general statutes.
- DME / Ambulatory lifts.

The Board voted unanimously that the scope of work for such apparatus is defined under CT General Statutes, Chapter 393, Section 20-330(7) as follows:

Sec. 20-330. Definitions (7) "Elevator installation, repair and maintenance work" means the installation, erection, maintenance and repair of all types of elevators, dumb waiters, escalators, and moving walks and all mechanical equipment, fittings, associated piping and wiring from a source of supply brought to the equipment room by an unlimited electrical contractor for all types of machines used to hoist or convey persons or materials, but does not include temporary hoisting machines used for hoisting materials in connection with any construction job or project.
