OLD BUSINESS:

1. Residential multipurpose fire sprinkler systems

- At the September meeting, the Board voted unanimously to table the topic of multipurpose residential fire sprinkler systems until such time that Richard M. Hurlburt, Director contacts the State of Ct., Office of the State Building Inspector, for clarification on whether or not residential multipurpose fire sprinkler systems can be installed and approved by the local authority.
