The CRRA's request dated June 20, 2013 for a variance from the limitations of the Municipal Transfer Station General Permit, for an increase in the tipping floor storage volume and for an increase in the time that the solid waste may be stored on the tipping floor, is hereby approved as follows:

*The tipping floor storage volume is increased to a maximum of 1,000 cubic yards and waste shall not be stored on the tipping floor for a period that exceeds forty-eight (48) hours, with the exception of legal holidays and weekends. The 48 hours begins when the solid waste is received at the facility and shall be processed on a first in first out basis.*

*The registrant is hereby authorized to operate a Municipal Transfer Station in accordance with the general permit issued by the Department on November 29, 2012.*

**This registration will expire on November 29, 2022.**

Dear Ms. Oakes:

Enclosed please find your copy of the Approval of Registration Certificate for CRRA's solid waste transfer station located on Route 154 in Essex, Connecticut. Staff of the Waste Engineering and Enforcement Division of the Department of Energy and Environmental Protection (the "Department"), have evaluated your request for a variance from the limitations of the Municipal Transfer Station General Permit (MTS GP). One of the two requests pertains to the tipping floor storage volume authorized for the tipping floor in the MTS GP and the other to the authorized duration that the solid waste may be stored on the tipping floor.

The MTS GP provides authorization for a Registrant to store up to 500 cubic yards (cy) at any time and for no longer than twenty-four (24) hours. Your request for variance seeks authorization to store up to 1000cy for a period not to exceed forty-eight (48) hours with the exception of legal holiday weekends. Your request is hereby approved with the condition that the 48 hrs begins when the solid waste is received at the facility and that the solid waste is processed on a first in first out basis.

Please also find the forms to be used for quarterly reporting in accordance with Condition No. I.5.J. of the Appendix of the General Permit, pursuant to Section 22a-209-9(p) of the Regulations of Connecticut State Agencies (RCSA).
