



# 2016 - 2017 Junior Hunter Season Pass for Permit-Required Hunting Areas

- This permit allows a licensed junior hunter and their accompanying adult licensed hunter to hunt small game on certain Permit-Required Hunting Areas without having to obtain the normal daily permits required of other hunters on these areas. When using this permit, the junior hunter must be accompanied by the licensed adult hunter named on the permit.
- This permit is valid for small game hunting only on the following Permit-Required Hunting Areas: East Windsor/Enfield, Hebron, NU-Maromas, NU-Skiff Mountain, Quinnipiac River State Park, Stanley Works, and Woodstock.
- Junior hunters may obtain multiple permits for themselves and other adult hunters. However, only one adult hunter is authorized by these permits for any given hunting trip.
- All parts of this permit application must be completed and signed by both hunters. The right side of the permit application must be detached and mailed immediately to the DEEP-Wildlife Division, 79 Elm Street, Hartford, CT 06106. The left side of the permit must be carried by the junior hunter while hunting.
- As a condition of using this permit, the junior and adult hunter agree to complete the survey on the reverse side of this form. Surveys must be submitted by March 1, 2017.

- This permit is valid for only one adult hunter per hunting trip. Multiple permits cannot be used on the same trip. Additional adult hunters who want to accompany the junior hunter must obtain a separate daily Permit-Required Hunting Area permit.
