

Re: **NOTICE TO MID-SIZE STATION APPLICANTS OF REVERSE AUCTION**

Dear Mid-Size Station Applicant:

The Department of Energy and Environmental Protection (“the Department”) Underground Storage Tank Petroleum Clean-Up Program’s second reverse auction will take place starting July 1, 2013 at 9 a.m. and ending on August 1, 2013 at 4:30 p.m., pursuant to Connecticut General Statute (C.G.S.) Section 22a-449r. As explained below, the reverse auction is the time for mid-size station applicants to establish their priority for payment in the fiscal year July 1, 2013 to June 30, 2014.

A. The Reverse Auction Process

The reverse auction takes place through the submission of payment elections by mid-size station applicants. Before the reverse auction begins, the Department will post on the Program’s webpage at www.ct.gov/deep/ustcleanup the amount that has been approved, the amount pending review, and prior payment elections under one dollar for each applicant in the mid-size station applicant category (without applicant names). The payment elections submitted by mid-size station applicants will serve as the bids for this auction.

The amount of each payment election that is less than one dollar will be posted on the Program’s webpage. The Department will seek to post payment elections no later than the next business day after receipt of a such information, but this cannot be guaranteed. For that reason mid-size station applicants may not want to wait until the last possible moment to submit payment elections.

Also, similar to bidding at an auction, a mid-size station applicant may submit more than one payment election during the time the reverse auction is taking place. Blank payment election forms are available on the Program’s webpage. at www.ct.gov/deep/ustcleanup. Once a mid-size station applicant submits a payment election, such applicant can only submit another payment election noting the applicant’s willingness to accept less that the amount noted in any prior payment elections.

B. Submission of Payment Election Forms

A [payment election form](#), including instructions, is enclosed with this letter and is also available on the Program’s webpage at www.ct.gov/deep/ustcleanup. Each mid-size station applicant must submit a new payment election form, except for those who bid 35 cents or less during the previous reverse auction. If a mid-size station applicant who previously submitted a payment election of 35 cents or less wants to submit a lower reduced payment election, it must be submitted between July 1 and August 1.

C. Establishing Priority for Payment

Priority for payment will be given to those mid-size station applicants who, through the payment election process, agree to accept the greatest reduction in the amount ordered, or to be ordered, paid from the Program, pursuant to C.G.S. Section 22a-449r. For example, if one mid-

size station applicant agrees to accept thirty-five cents on each dollar, this applicant will receive payment before every mid-size station applicant who elects to receive greater than thirty-five cents on the dollar. Through the submission of payment elections, the priority for paying mid-size station applicants will be established. If two applicants make the same payment election, payment for those applicants will be prioritized according to the applications for which payment was ordered earliest. In the case where two applicants make the same payment election and payment was ordered on the same day, payment will be prioritized according to the applications that were received by the Department earliest.

Please note that C.G.S. Section 22a-449r specifies the maximum amount that the Commissioner can pay to mid-size station applicants in any fiscal year. For the fiscal year beginning July 1, 2013, the amount is forty-five cents on that dollar (although those who elect the option under Section E below could receive an additional ten cents on the dollar). The reverse auction will determine the priority for payment among those mid-size station applicants who submit a payment election at or below the amount that can be paid in the fiscal year beginning July 1, 2013.

D. Considerations in Submitting a Payment Election

Given that each mid-size station applicant's circumstances are unique, the Commissioner strongly encourages each applicant to review carefully C.G.S. Section 22a-449r before submitting its payment election(s). While the following is not offered as advice or recommendation for any particular course of action, the Commissioner highlights the following for each mid-size station applicant's consideration.

- A payment election will apply to all of an applicant's applications, including those already submitted and those to be submitted in the future. An applicant cannot, then, have a payment election apply to only a portion of its applications.
- While the Commissioner cannot make payment to a mid-size station applicant in excess of 45 cents on each dollar in the fiscal year beginning July 1, 2013, (although those who elect the option under Section E below could receive an additional ten cents on the dollar), this amount will increase by ten cents each fiscal year, beginning July 1st, until it reaches \$1.00. Any mid-size station applicant who makes a payment election exceeding 45 cents on the dollar will not be able to receive any payment in the fiscal year July 1, 2013 to June 30, 2014.
- A payment election at or below the amount that the Commissioner is authorized to pay in a fiscal year is called a "reduced payment election." Mid-size station applicants who make a reduced payment election may, depending upon the availability of funding and the reduced payment elections from other mid-size station applicants, receive payment from the Program in the year any such reduced payment election is made. A mid-size station applicant who previously submitted a reduced payment election (i.e. thirty-five cents on the dollar or less) is not required to submit a new payment election. However, any such applicant may submit a new reduced payment election for less than the amount of any previous reduced payment election and in so doing potentially increase such applicant's priority for payment during the next fiscal year. Any such applicant, however, cannot submit a reduced payment election seeking more than the amount of any previous reduced payment election.
- The prioritization for making payment to mid-size station applicants will be based upon the payment elections that are received. If there are not enough funds available to pay all mid-size station applicants who have made a reduced payment election,

the priority for payment that has been established will remain in effect until additional funds are received. By submitting a lower reduced payment election, the priority for payment may be changed and can increase the likelihood of an applicant receiving payment from the Program more quickly. For example, if one year a mid-size station applicant elects to receive 35 cents on each dollar, such applicant in a subsequent reduced payment election may elect to receive *less* than 35 cents and through the resulting re-prioritization of mid-size station applicants receive payment more quickly.

- Except for mid-size station applicants who have already submitted a reduced payment election, failure to submit a payment election form will result in a mid-size station applicant not receiving payment in the fiscal year July 1, 2013 to June 30, 2014.

E. Agreement to Not Submit Any Additional Applications

A mid-size station applicant is also eligible to receive an additional ten cents on the amount paid from the Program by agreeing, in writing, not to submit any applications to the Program on or after October 1, 2012. If a mid-size station applicant has not and will not submit any applications on or after October 1, 2012, and wants to accept this option, check the box in Part III of the Payment Election form. Please note that this additional ten cents will **not** be counted when determining such applicant's priority for payment; such applicant's priority will be based upon the amount specified in Part II of the Payment Election form. Also, regardless of whether this option is exercised, a mid-size station applicant cannot receive more than one dollar on each dollar ordered paid, or to be ordered paid, by the Commissioner.

F. Submission of Payment Election forms:

Each mid-size station applicant's payment election(s) must be submitted on or after 9 a.m. July 1, 2013 but before 4:40 p.m. August 1, 2013. A payment election form can be submitted:

In the event of mailing, the Department will use the post-mark date as the date of receipt. In the event of personal delivery, the Department will use the date of delivery as the date of receipt.
