

UST Petroleum Clean-up Program Payment Elections Received from Mid-Size and Large Station Applicants

The Reverse Auction for the submission of payment elections by mid-size and large station applicants will begin 9:00 a.m. on July 1, 2016 and end August 1, 2016 at 4:30 p.m. Information about the payment election process and applicable forms was sent to all [Large Station](#) and [Mid-Size Station](#) applicants. Applicants are strongly advised to review Connecticut General Statute (CGS) Section 22a-449r and the payment election information noted above before submitting a payment election.

The tables below show information useful in making payment election decisions. The Amount Awarded is the amount previously awarded but not yet paid for each applicant as of June 28, 2016. Pending Review is the total amount requested but not acted upon for each applicant as of June 28, 2016. Actual payments may be less than the amounts shown on this table. The last column shows the latest payment election received from each applicant that is 99 cents or less. DEEP will seek to post payment elections here no later than the next business day after receipt of such information. For that reason mid-size station and large station applicants may not want to wait until the last possible moment to submit payment elections.

Each large station applicant, except those that bid 35 cents or less, and each mid-size station applicant, except for mid-size station applicants who bid 65 cents or less during the previous reverse auction, must submit a new payment election form. Any mid-size station or large station applicant that has not previously submitted a payment election and does not submit a payment election by 4:30 p.m. on August 1, 2016 will not be able to receive payment in the fiscal year July 1, 2016 to June 30, 2017 for any of its awarded costs.

If two mid-size station or large station applicants submit a payment election for the same amount, payment will be prioritized by which payment was ordered earliest. In the case where two applicants make the same payment election and payment was ordered on the same day, payment will be prioritized by which application was received first.
