That during the months of October 2013 - December 2013, a joint investigation was being conducted by the Connecticut State Police Computer Crimes Unit (CSP-CCU) and the Georgia Bureau of Investigation (GBI). The investigation was in regards to inappropriate image being sent to a juvenile via Kik messenger over the internet on cell phone.

That during the investigation a suspect was identified as Casey L Sotelo (d.o.b. 03/15/1987, CTOP# 037973526)

That during the investigation the victims phone was examined and there were pictures which were recovered from her phone which indicate that she had received adult male pornographic images from the suspect. That it became clear the suspect had received images from the victim clearly demonstrating that she was a juvenile.

OVERVIEW OF INCIDENT

That a Search Warrant was issued for the suspects residence where his cellular telephone was recovered and examined. That the suspects phone examination confirmed that he had been sending pornographic images to people over the internet via chat applications.

That based upon the facts and circumstances of this case associated with evidence and the suspects own statement, Casey L Sotelo was arrested and taken into custody.

Casey L Sotelo was charged with violations of C.G.S. 53-21 Risk of Injury / Impairing the morals of a Minor and C.G.S. 53a-194 Obscenity.

That Sotelo was processed according to department policy and procedure. That Sotelo was released after posting : \$25,000 surety bond set by the court. Sotelo was released at approximately 1200 hrs with an arraignment court da of 05/26/2015 at G.A. #3 Danbury Superior Court.
