OVERVIEW OF INCIDENT

In October of 2014, the Connecticut State Police Computer Crimes Unit initiated an investigation into the sharing of child pornography over the Internet. Subsequent investigation traced the Internet activity to a residence located at 903 Wheelers Farm Road, Milford, CT.

On December 14, 2014, the Computer Crimes Unit and the Milford Police Department executed a search and seizure warrant at 903 Wheelers Farm Road, Milford, CT. During the execution of the search warrant, Paolo Sassano was developed as a suspect. Several items of evidentiary value were seized from the residence. Troopers conducted a preview of the seized items and located files of suspected child pornography.

On May 18, 2015, Sassano turned himself in at Troop I - Bethany on an active arrest warrant. He was then processed according to department procedure and held on a court set \$150,000 bond. Sassano was transported to GA 22 Milford Superior Court for a same day arraignment.
