(Continuation of Criminal Information Summary)
Joseph Stephenson CFS #13-00133149

In the original incident, which occurred on 03/03/2013 at 10:49 PM, a suspect broke a window and entered the State's Attorney Office of the Norwalk Superior Court. When troopers responded to the activated alarm, the suspect fled through a rear door of the courthouse. Investigators found evidence inside the State's Attorney Office which indicated the suspect had been attempting to commit an arson.

WDMC detectives conducted an extensive investigation, which ultimately identified Stephenson as the suspect. An DNA Search Warrant was obtained for Stephenson, in addition to the Arrest Warrant. During processing for the Arrest Warrant, detectives attempted to execute the DNA Search Warrant. Stephenson failed to comply with instructions, which resulted in an additional charge of Interfering with a Search Warrant (Sec. 54-33d C.G.S.).

Stephenson was unable to post the \$150,000.00 bond, and remained in custody. He will be presented in Norwalk Superior Court on Monday March 24, 2014, for arraignment.

Stephenson received no injuries as a result of State Police processing.
