Vehicle #1 (State Police Cruiser 261-UTZ) was traveling on Interstate 91 northbound in the left lane of three (3) with its overhead and deck emergency lights activated assisting Ducci Construction on an Highway Construction Project (0246-dot-00820302CNI4). Vehicle #2 (CT 202-DTR) was traveling the left lane of three (3) approaching Vehicle #1. Vehicle #2 struck Vehicle #1 in the rear-end causing heavy damage to both vehicles. Operator #1 (Tpr. N. Ieraci #415 DOB:07/05/1984) sustained significant non-lifethreatening injuries as a result of the crash. Operator #2 (Devin Wallace DOB:06/20/1991) sustained significant non-lifethreatening injuries as a result of the crash. Both Operator #1 and Operator #2 were transported to Hartford Hospital for examination/treatment. Vehicle #1 sustained heavy rear-end damage and was towed from the scene by Plaza Towing. Vehicle #2 sustained heavy front-end damage and was towed from the scene by Danby's Towing. Enforcement action pending.
