**Meeting Minutes**

Meeting was chaired by Rick Macsuga as Chairman John Frassinelli was unable to be present.

Additions to the agenda:

Announcements from Agencies:

Mary Parizo announced that End Hunger CT! will be holding a symposium on hunger On Dec. 5 at Middlesex Community College – invitations will be sent out.

Bill Seedman discussed the upcoming reductions in SNAP benefits that result from expiration of increases that were made from the federal Stimulus program. Those benefit increases were sunsetted this month and 220,000 households in CT will see a decrease in dollar benefits. SNAP has about a \$4million dollar decrease in benefits this month.

Rick Macsuga reported that he has been asked to put together next year's program budget for state funded farmers' market coupons with a 10% reduction for WIC beneficiaries and a 20% reduction for seniors. Next year DOAG will have funds for a pilot program (probably in Bridgeport) of farmers' market coupons for veterans. They expect funding available to serve 1400 at-risk veterans.
