Games and game consoles are subject to limitation set by your property matrix (20). You are responsible for being within those limits. The console and games are subject to a limited warranty. The warranty is provided by the vendor - the Nintendo warranty is void due to alterations made to the unit in order to be sold by the CTDOC. This is the only warranty available, and you should consider this prior to placing your order. **You may only have one console in your possession. Order carefully - games are special-ordered for you and cannot be refused.**

- 1 -30 days - The unit will be sent back to the vendor. If it is a manufacturer defect the unit will be replaced or repaired at no charge. If the vendor examines the unit and finds the cause to be misuse or tampering then the warranty is void and you will be subject to the terms of expired warranty.
- 31 - 90 days The unit will be sent for repair for a \$5.00 shipping fee. A release of funds must accompany the item. The vendor will supply the call tag charged to you. The unit will be repaired not replaced. If unit is found to be misused or tampered with, the warranty is void and you will be subject to the terms of expired warranty.
- 91 + days. The warranty period expires. The unit will be repaired at your expense plus the \$5.00 shipping cost. You will be notified of the cost of repair.

**Individual games will be replaced up to two weeks from receipt. No other warranty will be given after that time.**

All replacements and repairs will be shipped via the district commissary. Any replacements will be engraved and a new receipt will be issued. The vendor will not accept any units that are not sent by the commissary with the commissary as the return address. Units sent outside of this procedure are sent at your own risk.
