Special Order Footwear

Special order shoes must meet the same requirements as shoes stocked in the Commissary (color, materials, etc.) You will not be allowed to buy shoes with colors or other "special features." Commissary will only special-order the shoes you select if you have enough money to pay for them. Special-order items take several weeks longer for delivery because they are ordered directly from the factory. They cannot be refused or returned. The commissary will not find footwear for reasons other than size restrictions. Medical issues must be handled through the medical department.

Tax will be added to all footwear. This form will take priority over regular purchases.
 The warranty that is provided by the manufacturer is the only warranty in effect. Please review and retain your warranty information.
 The commissary may be able to assist with replacing items defective at the time of delivery.

Note: Numbering on Men's shoe sizes is 1-1/2 to 2 sizes smaller than women's. When ordering a shoe listed as "Men's Shoes", be sure to order 1-1/2 to 2 sizes smaller than your women's size (for example, size 9 Women's is Men's 7 or 7-1/2)
