1. Anticipated costs and charges originating from utility companies for coordination with, connection, all costs of work from the face of the building to the provided utility
- B. Allowance No.2 Testing and Inspection Allowance:
 1. This allowance includes all costs for testing and material Inspections specified in Section 033000 "Cast in Place Concrete", Section 052100 "Structural Steel", and Section 31 66 15 "Helical Piles".
- C. Allowance No. 3 Lump Sum Allowance:
 1. This allowance includes all costs for the restoration of turfs and grasses, plants, pavements, and other surface improvements disturbed by construction activities.
- D. Allowance No. 4 Lump Sum Allowance: Includes the sum of \$2,500.00: Includes all costs to repair cracking to drywall due to elevating house.
 1. This allowance includes material cost, repairing cracks in drywall, and painting and Contractor overhead and profit.


