

Protective Order (“Motion”) requesting an exemption from public disclosure. The Motion shall provide specific legal arguments with reference to state or federal law describing with supporting facts why the information should be kept confidential. A certified affidavit supplied by a competent witness in support of the Motion, a proposed protective order and nondisclosure agreement must be appended to the Motion. The confidential material itself must be submitted in hard copy only to the Departments for *in camera* review by the Departments. Each page of the confidential information shall be stamped “CONFIDENTIAL,” and the material shall be placed in a sealed envelope marked “CONFIDENTIAL – NOT FOR PUBLIC DISCLOSURE.” Do not send any proposed confidential information electronically to the Departments.
